- The Institution is recognized by AICTE, New Delhi and affiliated to Visvesvaraya Technological University (VTU), Belagavi.

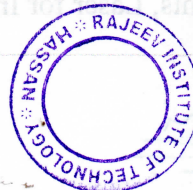

Permission:

Government Tool Room & Training Centre and said **Department of Electrical & Electronics Engineering, Rajeev Institute of Technology, Hassan (T&D),**

shall establish collaborations for the purpose of:

- Carrying out internship programmes for enhancing the knowledge and skills of students.
- Carrying out project works to promote overall development of students and make them industry ready.
- Arranging industrial visit to students, to orient them to industrial environment and to interact with professionals.
- Conducting seminar by resource person from the said institution to enhance the knowledge of faculties and students.
- The minimum of **100 Candidates/year** has to be trained under **Centre of Excellence(COE)** & other short term courses at GT&TC Hassan.

Conduct of various programs, events etc.

- The said courses / programs / events called by any name shall be conducted by said institution and **Government Tool Room & Training Centre** in collaboration and shall be overseen by a standing committee consisting of two representatives each of company and institution.
- The venue of the said courses, programs, events called by any name shall be decided and conducted by mutual understanding of both the parties.
- The content and delivery of the course / program shall be designed by mutual understanding by both the parties.

Goodwill:

The **Department of Electrical & Electronics Engineering, Rajeev Institute of Technology, Hassan, (T&D),** both shall Endeavour to maintain, promote and improve the goodwill and image of both the organizations.

Tenure:

This Memorandum of Understanding shall continue to be in operation for a period of **two years** commencing from the date of signing this MOU. Upon the expiry of this Memorandum of Understanding and/or six months prior thereto, both parties are entitled to the renewal of the Memorandum of Understanding for a future period of two years by issuing a written notice to the other to that effect. Upon the extension notice being issued to either party and upon acceptance thereof, this Memorandum of Understanding may be continued beyond the period of **two years** on the terms and conditions as may be mutually agreed upon between the **Government Tool Room & Training Centre** and said institution.

Termination

1. If there is a breach of any of the conditions by either party, then Memorandum of Understanding may be terminated with one-month prior notice by either party without affecting the students or participants of larger interest.

On Termination:

On termination of this Memorandum of Understanding:

- a) No joint, collaborative programmes, called by any name shall be undertaken by either of the institutes thereafter.

Neither **Government Tool Room & Training Centre** nor the said **The Department of Electrical & Electronics Engineering, Rajeev Institute of Technology, Hassan, Hassan (T&D)**, shall be responsible for any loss or damage which may be caused because of destruction of any materials, cancellation of any programmes or in any other manner or on account of termination of the Memorandum of Understanding.

- b) Parties hereto agree to settle outstanding dues if any.

Neither **Government Tool Room & Training Centre** nor the **Department of Electrical & Electronics Engineering, Rajeev Institute of Technology, Hassan (T&D)**, shall have any right or title or interest in the name and goodwill of the other party.

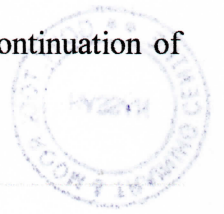
- a) None of the parties shall, after termination of the Memorandum of Understanding claim, advertise or suggest any association with another party.


